Consideration of Funding Year 2021 Filing Window Dates

Action Requested

The Schools & Libraries Committee (Committee) of the USAC Board of Directors (Board) is requested to authorize USAC to open the Funding Year (FY) 2021 application filing window no earlier than January 2021, and to close the window no earlier than March 2021.

Discussion

A Funding Year 2021 filing window opening no earlier than January 2021 and closing no earlier than March 2021 will provide a reasonable time period for applicants to submit their FCC Form 471 funding applications. The application filing window has typically been opened in the first quarter of the calendar year, which strikes a balance between giving applicants time to complete their competitive bidding reviews while providing USAC time to review the applications so that funding decisions can be issued before the school year starts. We used this same timeframe for FY 2020, and even with the FCC's extension of the filing window until April 29, 2020 due to the coronavirus pandemic, USAC was able to issue funding commitments for over 90% of workable applications by September 1, 2020. While many factors played a role in the timely issuance of decisions, a key factor in past funding years was opening and closing the application filing window in the first quarter.

USAC is requesting approval to open the FY 2021 application filing window no earlier than January 2021, and to close the window no earlier than March 2021. This timeframe aligns with the Application Filing Window dates over the past few years and will help USAC to issue timely funding commitments.

Section 54.502 of the Federal Communications Commission's (FCC) rules mandates that the filing window cannot open until sixty (60) days after the release of the Eligible Services List (ESL) by the FCC. The FCC issued a public notice seeking comments on the proposed Funding Year 2021 ESL on July 21, 2020. The FCC had not issued the FY 2021 ESL as of October 7, 2020.

E-Rate Scorecard

- 38,683 total applications are considered "In Window" requesting \$2.96 billion
- 34,819 applications (90%) have been reviewed/processed for \$1.68 billion in commitments (\$1.9 billion reviewed) through Sept. 30.


FCC Order DA 20-1091 (released Sept. 16, 2020)


- Second FY 2020 window for bandwidth requests (Sept. 21 to Oct. 16, 2020)
- The Order does not require a new competitive bidding process, but participants must complete any competitive bidding that may be required under state and local laws.
- USAC shall grant funding requests where the price per megabit is the same or less than the original contract. If price per megabit is higher than the original contract, USAC will limit the funding commitment to the price per megabit in the original contract.
- The Order does not relieve service providers of their obligation to offer the lowest corresponding price for services.
- The Order requires applicants to provide additional information in the narrative section of FCC Form 471 about the price per megabit in both the original and new funding requests. In addition, applicants must highlight any difference in pricing to facilitate and expedite USAC's review.

- FY 2020 Fiber requested dollars continue to trend lower year over year.
- FY 2020 Fiber application counts also continue to trend lower with dark fiber and self-provisioned applications at a four-year low.

SL 3Q2020 Updates & Accomplishments:

- Achieved 91.6% completion of workable FY 2020 applications as of 9/1/2020.
- Cumulative FY 2020 commitments through 3Q2020 total \$1.68 billion for 34,819 applications. As of September 30, 4,399 application reviews were in progress (\$1.06 billion requested).
- Committed 916 of 1,121 (81.7%) FY 2020 fiber apps for \$114 million through September 30; 205 applications remain pending for \$182 million.
- 93.6% of Category One applications completed committing \$1.12 billion as of September 30. 1,522 applications in review requesting \$585.4 million.
- 84.4% of Category Two applications completed committing \$521 million as of September 30. 2,342 applications in review requesting \$585.4 million.
- 1,290 of 1,774 FY 2020 Consortia applications completed committing \$131.1 million; 484 applications in review requesting \$279.5 million.


Overall Schools and Libraries Activities:
