

FCC Form 481 Filing Guide

ETCs receiving support from the High Cost and Lifeline programs must file the FCC Form 481 on or before July 3, 2023.

For ETCs with rates below the benchmark, report rates and lines on <u>Rate Floor Data Collection Report and Certification</u> (see 47 C.F.R. Sections 54.313(h) and 54.318).

Before filing, review the <u>FCC Form 481 Instructions</u> (revised 2020). ETCs should complete sections of the FCC Form 481 <u>electronically in One</u> Portal as follows:
